TO OUR STUDENTS AND PARENTS

Mazon-Verona-Kinsman Elementary School District 2C would like to take this opportunity to familiarize you with the various extra-curricular programs offered by our school and to acquaint you with the guidelines and regulations that help run our programs in a manner that best provides our students a meaningful, growth-oriented, and competitive experience. Most of the extra-curricular programs offered at M.V.K. are sanctioned by the Illinois Elementary School Association (I.E.S.A) and are bound by their guidelines and by-laws. **It is important to note that participation in any of our extra-curricular activities is a privilege, not a right, offered to our students.**

Communication is a vital ingredient for success in any program. If at any time you have a question or concern regarding extra-curricular activities, please contact the COACH(es) first, then the ATHLETIC DIRECTOR, then the PRINCIPAL. We will do everything possible to address your concerns and questions.

Since communication is vital, it is our expectation that parents and students read and discuss the contents of this extra-curricular activity handbook. Extra-curricular activities can be a rewarding experience in a person's life and it is our hope that our programs will provide a stimulating and invigorating component to our students' educational experience.

MAZON-VERONA-KINSMAN ELEMENTARY SCHOOL DISTRICT 2C EXTRA-CURRICULAR PHILOSOPHY

There are multiple goals to the philosophy of our extra-curricular program. The idea of working hard to learn the basic concepts and skills in extra-curricular activities carries over to the classroom and life after formal schooling.

1. It is our aim to show that everything achieved is earned through thinking, working and perseverance.
2. A sense of school pride and spirit should also be developed by the participants, the teams, the school and the community.
3. A will to win and achieve success should be developed, but not at the expense of good sportsmanship and /or cooperative teamwork.
4. Winning with humility and losing with dignity is an important value that should be developed.

Extra-curricular activities are only one aspect of a person's development, but hopefully, they will be an important adjunct to your child's educational experience in school and will carry over to real-life situations.

Extra-Curricular Programs Offered

Mazon-Verona-Kinsman Elementary School District 2C is a member of the Illinois Valley Conference (IVC) and the I.E.S.A. Other conference members are Channahon, Coal City, Dwight, Elwood, Gardner, Minooka, Reed-Custer, Saratoga, Seneca, Shabbona, and Wilmington. Approximate seasons follow the sports. Some of the seasons may vary slightly. Coaches will designate on schedules if it is an "Open Gym" versus a "Practice".

General Guidelines

SELECTION GUIDELINES

MVK is a member of the Illinois Elementary School Association (IESA) and will follow its guidelines for number of athletes participating on our 7th and 8th grade teams for the regular season and for tournaments. IESA regulations state that on tournament teams, there may only be up to 15 participants on a team in the following sports: girls' basketball, boys' basketball, and volleyball. There may be up to 18 members on a team in baseball and softball. Those team members may be from any grade level, except 8th graders cannot play on the 7th grade team. MVK Middle School will give opportunity for 6th grade participation when possible. Please remember that MVK does not have an official 6th grade program. Any involvement at that level should be considered developmental and does not guarantee playing time. 5th grade participation is not available unless deemed necessary by the administration.

Note: *When the number of eligible participants for an extra-curricular team is just one more than the anticipated need, that one additional person will be kept on the roster during the regular season. It will not be the practice of M.V.K. to eliminate just one player from any squad.*

ACADEMIC ELIGIBILITY (“3” strikes and you’re out)

Academic eligibility is determined on a weekly basis starting with the first official try-out date. An ‘F’ will count as a strike beginning the week of the first game. Students must be passing all classes in order to be eligible. Teachers are required to post grades before 8 A.M. each Monday. These grades are to reflect a student’s academic progress through the previous week.

An ineligible student will follow the procedure below:

First and Second offense- student will attend Homework Class during intervention time. Student may attend practice, but may NOT attend or participate at games, both home and away.

Third offense- student is removed from the team.

***Students will not attend the game/meet for which they are ineligible. It is the expectation of the administration that the student will stay home to work on academics. **Once grades have been posted and checked, neither the Coach nor the Parents will revisit them. The ineligibility remains in effect until the following week.**

PLAYING TIME

Participation and/or activity fee does not guarantee playing time **at any grade level**. Playing time is determined by the coaching staff and supported by the administration. Coaches will attempt to play all team members, when the situation presents itself.

LIMITATIONS OF ACTIVITIES

If a student has a note from a licensed physician, which limits the student’s ability to perform in their regularly scheduled physical education class, they must also abstain from practice/games until the limit is lifted.

Furthermore, any student sitting out of PE for **ANY** reason will not be allowed to practice or play in a game that day.

CONTESTS/PRACTICES

Participants are expected to attend all scheduled practices and contests unless the coach grants **prior** excused clearance. Participants are to schedule necessary appointments away from scheduled practices and contests.

Note: See page 8 for consequences.

SCHOOL ATTENDANCE

Students must be in attendance for at least half of the instructional time on the day of an extra-curricular practice and/or contest and be present at the end of the day in order to participate **Note:** *Doctor* appointments that require a student be removed from the school after 12:00 will be excused if verified through a receipt.

INJURIES

All injuries, no matter how minor in nature, should be reported to the coach immediately. If a participant must see a physician for an injury, the participant will not be allowed to resume practicing or competing without the physician's consent.

APPEARANCE

Students who represent the school in interscholastic extra-curricular activities are expected to dress in a neat respectable manner. Their actions and conduct are a direct reflection of the overall quality of our extra-curricular program and school. The coach and/or sponsors may establish rules regarding a particular dress style for their own team.

EQUIPMENT AND UNIFORMS

Students participating in extra-curricular activities are responsible for the safe return of all equipment and uniforms issued to them. Participants should inspect all personal equipment each day before practice or contests. Unsafe equipment should be reported to the coach immediately. Participants will not be permitted to receive awards or participate further in any extra-curricular activity until all equipment and uniforms are returned or paid for.

DETENTIONS/SUSPENSIONS: ATHLETIC ELIGIBILITY

“AFTER-SCHOOL” DETENTION – Detention lasts until 4:00 P.M. Students may go to practice or a home game after detention. A student may only attend an away game if the bus leaves after detention.

“IN-SCHOOL” ISOLATION, “IN-SCHOOL” HOMEWORK DETENTION, and “OUT-OF-SCHOOL” SUSPENSION – If a student is serving any of these, he/she is not eligible to participate in an interscholastic practice or contest until the day he/she is allowed to return to class. This means that the student may not attend a practice or contest until the day after the suspension has been served. *(A student suspended through Wednesday may not practice/compete until Thursday.)*

ACADEMIC/ ATHLETIC OVER-LAPS –Students enrolled on both an academic and athletic extra-curricular activity at the same time will occasionally have scheduling conflicts. When a conflict occurs, a “Contest or Meet” always take precedence over a “Practice”. In the case that a major contest is just a day away, practice may then also take precedence. Coaches will be in communication in order to make determinations in the case of a question about procedure.

TRANSFER STUDENT ELIGIBILITY

A student who transfers from another school to MVK shall become eligible upon the eleventh day of attendance at MVK provided all eligibility requirements have been met. The student can practice but can't participate in games until the eleventh day of attendance.

TRANSPORTATION

All team members must leave and return with the team via transportation provided by the school. Team members will be allowed to go home with parents or a designated adult, with written consent from their parents, only if the coach agrees and only after they have been signed out. Special arrangements can be made prior to the game, if a

student needs to be driven to a game from a medical appointment. Please note that these transportation rules are for ALL extra-curricular events.

Extra-curricular participants are expected to obey all rules and follow the directions of the bus driver at all times. The same bus rules that apply to school also apply during extra-curricular trips. Failure to abide by these policies subjects the participant to a possible suspension from the bus and consequently, removal from the team.

Parents are responsible for prompt pick up of extra-curricular participants after practices and contests. Most pick-ups will take place in the front of M-V-K Middle School. Practice dismissal will be listed on practice schedules. Athletes may need to call parents for rides after contests so please anticipate these calls.

When possible the students will call prior to returning to MVK. Please note that a "3 strike" system will be applied for picking up your students. Our coaches/teachers will wait 15 minutes after practices/games before your student is given a strike. When a third strike is issued, the student is dismissed from the team. For extenuating circumstances, please contact the Athletic Director. **(These 3 strikes coincide with the strikes for absences from practices and contests.)**

Student/ Parent Responsibilities

Prior to the Season-In order for a student to be eligible to participate in any extra-curricular **athletic** activity, they must have four (4) important documents on file with the Athletic Director in the school office.

1. **A current physical** - Prior to try-outs for an athletic team, a participant must have a current **SPORTS PHYSICAL** which is dated no earlier than 395 days (13 months) before the END of the practicing sport's season. There are no exceptions to this rule! Students will be counted as missing a practice for every day they do not have a completed physical form turned in. Please see "Unexcused Absence From Practice" in the Offenses and Disciplinary Actions area for consequences. **(Please Note - As a service to our students and parents, Sports Physicals are conducted each summer at Dr. Comfort's office. The dates are listed in the pre-registration packet.)**
2. **A copy of the participant's birth certificate-** must be on file for the IESA to prove age eligibility.
3. **An extra-curricular form-** must be on file to be able to release participants for emergency medical care if needed and to state that you agree to the terms.
4. **Concussion Form** – must be on file with the Athletic Director prior to the first game.

These documents can be picked up during school registration in the summer at the school office, from the coach, or from the Athletic Director. Students will not be allowed, under any circumstances, to try out or participate without these on file with the Athletic Director.

Participation Fee

- \$25 - each athletic team
- \$20 - Bowling
- \$15 - Scholastic Bowl
- \$10 + individual entry fee – Speech Contest, Music Contest
- \$5 - Spelling Contest, Math Contest

These fees are used for equipment, officials' fees, busing, etc. Payment of this fee does not guarantee playing time. This financial obligation must be met prior to the first competition. Students experiencing a financial hardship are encouraged to apply for monetary assistance. Students who qualify for "Free/Reduced" lunches are usually granted this waiver.

Student/ Parent Sportsmanship

Sportsmanship is everybody's responsibility. Sportsmanship starts on the court or athletic field and extends into the bleachers and beyond. It is everybody's responsibility to practice good sportsmanship. Recognizing the efforts by students, coaches, administrators, spirit groups, and fans is a valuable part of the extra-curricular experience.

IESA Requirements for all Coach/Sponsors, Participants, and Spectator Ejections

Coach/Sponsor 1st offense – Two game immediate suspension, completion of NFHS Sportsmanship course, and \$100 fine.

Coach/Sponsor 2nd offense – Five game immediate suspension and \$250 fine

Participant 1st offense – Two game immediate suspension at the level the ejection occurred and all games in the interim as well as completion of the NFHS Sportsmanship course.

Participant 2nd offense – Five game immediate suspension and \$100 fine.

Spectator 1st offense – Completion of the NFHS Sportsmanship course.

*All courses and fines need to be received by the IESA Office from MVK prior to any return.

Spectator Code of Conduct

All spectators are to respect the talents and efforts put forth by the participants and coaches/sponsors of all teams/clubs. This courtesy will also be extended to all game officials. Furthermore, spectators are to treat school representatives and other spectators with dignity and respect. Any actions that are counterproductive to these expectations are in bad taste and will not be tolerated. Spectators not conducting themselves appropriately will be subject to any of the following actions, depending on the severity of the incident:

1. The spectator may be asked by any school representative to refrain from further inappropriate action.
2. The spectator may be asked by any school representative to leave a school activity. Should a spectator refuse to leave when requested, a local law enforcement agency will be contacted for assistance. Once a spectator has been removed from a school activity, a school official will hold a conference with the spectator to resolve the issue and the spectator must complete the IESA Requirements prior to attending future activities.
3. Severe or repeated offenses may result in the request of a "No Trespassing" letter from the Board of Education and/or the contacting of local law enforcement agencies.

Guidelines for Spectators at Extra-Curricular Events

So that each parent, student and guest may enjoy viewing contests and events at M-V-K and in order to keep playing conditions as safe as possible for participants, we expect all spectators to observe the following guidelines:

1. Treat performers and other spectators with respect (no booing or hissing)
2. We expect people to be loud, but appropriate. Being appropriate means:
 - Applaud and listen at the appropriate times
 - Remain seated during contest action
 - Enter and exit through designated exits quietly during breaks
 - Use proper language (no profanity)
 - Be safe at the contest. Being safe means-
 1. No foot stomping in the bleachers
 2. No running, jumping, or horseplay
3. NO SMOKING on school grounds. This includes vehicles in the parking lot and spectators at the Mazon Park for practices and games. This rule includes the use of e-cigarettes.

Spectators who violate these guidelines will be dealt with in accordance to the spectator code of conduct delineated above.

Participant Sportsmanship Guidelines

Athletes are representatives of their school and community. Their sportsmanship must reflect this before, during, and after contests. Good sportsmanship is a prime objective of the Mazon-Verona-Kinsman Elementary School District 2C and will be expected of its participants. Participants should conduct themselves in a sportsmanlike manner at all times. This type of sportsmanship can be displayed by:

1. Abiding by the decisions of all game officials at all times
2. Respecting the talents and efforts of **ALL** players and coaches at all times
3. Controlling your emotions. Keep your composure when player and fan emotions are running high.
4. Developing good attitudes and character. Developing integrity in yourself.
5. Respecting your fellow athlete for himself/herself and not according to race, creed, or religious beliefs.
6. Report any concerns to the coach.

Procedures for Contacting Coaches

Coaches and sponsors strongly encourage an open line of communication with the parents of their team members, in order to provide the best possible extra-curricular program for a student. In the event that there is a controversy concerning a participant's status on the team, and a parent feels that some clarification is necessary, the following guidelines should be followed:

1. The **DAY AFTER** the contest or practice, the parent should contact the coach at the school and hopefully clarify any misunderstandings. This contact should be done away from the team members. Parents should refrain from approaching a coach during or after the sporting event about playing time, practice time or any other concerns. An appt. should be made the day after the sporting event. In the event these procedures are not followed, a parent will be asked to refrain from attending the next contest.
2. If the concern persists, then a conference with the Coach, Athletic Director and Parent will be scheduled.
3. In the event another meeting is necessary, the Principal, the Coach, Athletic Director and Parent will schedule a conference.
4. Before any issue or problem concerning extra-curricular activities is brought before the Board of Education, a final meeting with the superintendent and his/her designees is required.

Eighth Grade Recognition Night

Depending on the activity, eighth grade students and their parents may be recognized at **a competitive match toward the end of the season for each sport.** Please mark your calendar and plan to attend.

Additional Parent Responsibilities

Some interscholastic programs will require that parents assist in a variety of ways. It will be the Coaches responsibility to develop schedules for these extra parental duties. If parental participation is insufficient, then coaches will meet with the athletic director to discuss options.

Supervision – Coaches are expected to provide parents with a practice/game calendar specifying when participants are to be picked-up. We ask that students not arrive before 10 minutes prior to practice and that parents be on time to pick up after practice. Coaches are not permitted to leave until all students have been picked-up.

Open Gym – Some Coaches provide extra opportunities for students to practice before the season actually begins. These practices are “completely” optional. These open gyms will be clearly marked as such on

coach's schedules. Coaches also understand that they may not overlap with any other sport currently in season, unless approved by administration.

Practice Times – Parents need to be prepared for a variety of practice times. Coaches will do their best to ensure that the times do not interfere with a student's academic commitments. Students not able to practice at given times, will be held accountable to the "strike" system that each coach is required to maintain.

Laundry – Parents will be responsible for a minimum of one team uniform wash for Girls Basketball, Boys Basketball, and Girls Volleyball. All laundry is completed at the Middle School and can be done the night of the game or the next day. Coaches will have a sign up sheet and directions will be in the laundry room.

Code of Conduct for Mazon-Verona-Kinsman Elementary School District 2C Extra-Curricular Participants

Purpose

Students of Mazon-Verona-Kinsman Elementary School District 2C who take part in any school sponsored activity represent our school and community by their actions and conduct. The administration, coaches, sponsors, teachers, and parents of M.V.K. take pride in our student body; therefore, we require that they demonstrate behavior becoming to our expectations. Participation in extra-curricular activities is an honor and privilege, but not a right. This privilege may be revoked when actions or behaviors are in violation of this Code of Conduct.

Application and Enforcement

The code of conduct applies year-round to any student enrolled at Mazon-Verona-Kinsman Elementary School District 2C who is involved in extra-curricular activities. It is understood that the consequences delineated below are the minimum penalties you may expect. The coach, sponsor, and or Athletic Director may recommend or enforce more severe measures depending on specific situations, attitude, and cooperation.

**It is the responsibility of the Athletic Director to enforce the disciplinary measures outlined in the Code of Conduct. The Athletic Director and coach will determine the consequences for any offense not specifically addressed in this code.

Reporting of Incidents

It is the responsibility of any coach, sponsor, administrator, or faculty member of Mazon-Verona-Kinsman Elementary School District 2C or law officer who has witnessed, has proof of, or has an admission from an extra-curricular participant, who has committed one of the offenses listed below to report to the Athletic Director immediately.

Offenses and Disciplinary Actions

1. Tobacco, alcohol and Drugs – It is a violation to use or illegally possess tobacco, alcohol and/or drugs.
 - a. First offense- 40% suspension from all extra-curricular activities during the season that the offense occurred. If the suspension was at the end of the season, the suspension shall run into the next activity the student participates in.
 - b. Second offense- a one- (1) calendar year suspension from all practices and activities.
2. **Theft or vandalism of/on school property** – it is a violation for an extra-curricular participant to commit an act of theft or vandalism on school property.
 - a. First offense- suspension from all extra-curricular activities during the season that the offense occurred.
 - b. Second offense- a one- (1) calendar year suspension from all practices and activities.
3. **Conviction of a misdemeanor act** – any extra-curricular participant who is convicted of a misdemeanor crime shall receive the following.
 - a. First offense- suspension from all extra-curricular activities during the season that the offense occurred.

- b. Second offense- a one- (1) calendar year suspension from all practices and activities.
- 4. **Misbehavior**- Minor misbehaviors will be addressed by the coach/sponsor. If poor behavior persists, and after notification to parents, it will be considered “gross” misbehavior, and consequences will be as listed in that category.
- 5. **Gross Misbehavior**- any extra-curricular participant who commits a gross misbehavior shall receive the following:
 - a. First offense- a minimum suspension of 30% of a sport or activity’s total number of games or contests.
 - b. Second offense- a one- (1) calendar year suspension from all practices and activities.
- 6. **Conviction of a Felony Act**- any extra-curricular participant who admits, is convicted of, or pleads guilty to committing a felony shall be suspended for (1) calendar year from all practices and activities.
- 7. **Unexcused absence from practice or from a contest** – any extra-curricular participant who, in the opinion of the coach, is unexcused from practice or a contest shall receive the following:
 - a. First offense – **Strike 1** - Athlete will not start in the next game
 - b. Second offense – **Strike 2** - a one (1) game suspension – athlete will NOT attend the game.
 - c. Third offense – **Strike 3** – the athlete is removed from the team.
- 8. **Behavior Signatures/Office Visits** – Students who are sent to the office for inappropriate behavior THREE times or who have had a combination of 6 or more signatures in the Behavior category of the responsibility card and/or office visits throughout the current semester will not be allowed to participate in any extra-curricular program for the duration of that semester. Students deemed ineligible for a program within the first semester may resume participation of that program after two weeks into the semester.

Suspension Commencement

Suspension will begin when the extra-curricular participant meets with the Athletic Director and Principal immediately following notification of the offense. If the extra-curricular participant is not involved in any activity at the time of the offense, the suspension will be enforced at the beginning of the next activity in which the extra-curricular participant competes. If an extra-curricular participant is suspended during an activity’s season and the suspension is not fully served upon completion of that season, the remainder of the suspension will be served at the beginning of the next activity season in which that extra-curricular participant competes.

Team Rules

In addition to the guidelines of this Handbook, the Coach may have further rules and regulations. If so, upon prior approval of the Athletic Director, they will be given to the parents and participants in writing. It is then the coach’s responsibility to make sure that his/her team understands and receives a copy of those rules.

Right of Appeals – Due Process

The Athletic Director will advise the principal of the exact consequences of all discipline infractions. Each discipline situation is unique and must be dealt with on an individual basis.

There is an established procedure, which provides for the appeal of disciplinary actions as follows:

1. The complainant shall first bring the complaint to the coach involved.
2. If a problem cannot be resolved, then it will be brought to the attention of the Athletic Director.
3. If a problem is still not resolved, then it will be brought to the attention of the Principal.
4. The complainant may refer the issue to the superintendent by requesting an appointment in writing for a review and decision.
5. If the above steps do not resolve the concern by the complainant, they may request a closed meeting with Board of Education in writing.
